Confidential Policy

We take your right to privacy very seriously and want You to feel secure and comfortable while using this resource. All information published by users of this resource in the user's personal account, and all information about the activities of any other person associated with it, is confidential.

We strictly stand by the following principles:

- we will not sell or transfer Your personal information to third parties, except in cases where the provision of this information is required by existing legislation and required by public authorities;

Registration

Confidential Policy changes

We reserve the right to make any changes to our Confidential Policy. If there are significant changes that affect your personal information, we will notify You at the main email address specified in our system.

Other conditions

While this Confidential Policy states our standards of service, we will make efforts to protect Your data, but there may be factors outside of our control (force majeure) that may result in data disclosure. In such cases, we disclaim any guarentees or conditions relating to the service or non-disclosure of Data.

We will assume that all information you send to our email address is not confidential unless the "Confidential" mark is made.

The provision of this Confidential Policy remains in force and is binding on the Parties both during the entire term of the service and in the future.

For the functioning of the site, as well as for our own statistical analysis of traffic, we keep statistics of IP addresses of visits.

The system DOES NOT record email addresses.

The gathered information is in no way associated with specific users, and is processed only in the form of generalized statistics.
